Striking out the following:

<u>Environment, Parks and Energy Committee:</u> The Environment, Parks & Energy Committee works to promote and protect open space in Jamaica Plain, raise awareness of green issues in Jamaica Plain and advises on neighborhood energy issues. Responsibilities of the Committee include fostering community around parks and green space; networking with other existing organizations and programs related to maintaining and protecting open space and the environment; advocating for parks and open space and advising on matters related to environmental sustainability, protection and restoration,

and by substituting therefor the following:

<u>Environment, Parks & Energy Committee:</u> The Environment, Parks & Energy Committee networks with other organizations and programs and engages in the following activities: (1) Advocates for a range of environmental issues in Jamaica Plain and comments on, raises awareness on, and promotes matters related to, sustainability, environmental protection, the urban forest and urban agriculture; (2) Advocates for the protection and creation of parks and open space in Jamaica Plain and fosters community around parks and green space; and, (3) Advocates for neighborhood energy efficiency, renewable energy, and other carbon reduction issues.

(b) The Council, pursuant to Article 12 of the by-laws and for "good cause shown" within the meaning of said Article 12, VOTE to "consider removal" of Bruce Marks as a Council

 - (a) 25 Amory Street (Jackson Square Site III), new construction of 44 residential units in fourstory, 47,900 square foot building for affordable rental housing;
 - (b) 28 Cornwall Street splitting of existing first floor unit into two individual units and convert from three-family to four-family occupancy no exterior modifications; and,
 - (c) 11 Dane Street, construction of 145 sq. ft. first-floor addition to rear of existing single-family residence; and,

 - (a) To send an Article 80 comment letter to the BPDA re: The project proposed for 1785 Columbus Avenue by a partnership of Watermark Development and Horizons for Homeless Children, noting that the developer: (1) will continue community outreach and is open to considering additional changes/suggestions; (2) will contribute community benefit beyond the DIP linkage funds; (3) will pay reasonable pay and job standards; (4) will ask the general contractor and subcontractors working on the project to bring on an intern for job training, and to give job preference to parents involved with Horizons for Homeless Children; (5) will explore ways to work collaboratively to improve the job opportunities for people who will be working in the offices at this site, and for the parents involved with agencies located at this site, and will meet with the community about that.

An additional comment to be included in the comment letter is that this project highlights the need for thoughtful traffic planning for the area around Amory Street near Jackson Square, an area that is scheduled for much development over the next several years
